

**ORDINANCE NO. 96, SECOND SERIES**

**AN ORDINANCE OF THE CITY OF TWO HARBORS, MINNESOTA, AMENDING  
THE CITY CODE, CHAPTER 9, PARKING REGULATIONS**

**THE CITY COUNCIL OF THE CITY OF TWO HARBORS DOES ORDAIN:**

**Section 1.** Section 9.03, Recreational Camping Vehicle Parking. Section 9.03, Subd. 1, is hereby amended by changing the title of the Section to: Section 9.03, Recreational Vehicles/Equipment Parking, by amending the term “recreational camping vehicle” in the introductory sentence of Subd. 1 to “recreational vehicle/equipment and by adding the following definition:

“E. “Other Recreational Equipment” - Includes but is not limited to boats, snowmobiles, jet skis, all-terrain vehicles, go-carts, mud trucks, stock cars, buses, truck toppers, enclosed box trailers, golf carts, side-by-sides and any trailer capable of carrying any of the foregoing items of equipment.”

**Section 2.** Section 9.10, Resident Permit Parking Zones. Section 9.10, Resident Permit Parking Zones is hereby deleted.

**Section 3.** Section 9.21, Subd. 3, Recreational Vehicles/Equipment. Section 9.21, Subd. 3, Recreational Vehicles, is hereby amended to read as follows:

“**Subd. 3. Recreational Vehicles/Equipment.** It is unlawful to park recreational vehicles/equipment on any street, avenue or alley other than on a temporary basis (defined as less than 24 consecutive hours) once in any seven consecutive calendar day period. Violators may be ticketed and/or towed at owner’s expense. This shall not apply to:

A. Construction trailers/equipment while temporarily engaged in building or remodeling with a valid permit.

B. Towed trailers while the driver of the towing vehicle is engaged in the performance of his/her usual trade or occupation.

C. Emergency or utility services engaged in temporary performance of duties.

D. Persons violating this subdivision shall be subject to penalties as described in Section 9.99.”

**Section 4.** Added to Code. The terms and provisions of the foregoing Ordinance shall be added in the appropriate place in the Two Harbors City Code after adoption and becoming effective.

**Section 5. Effective Date.** The foregoing Ordinance shall be effective: (a) thirty (30) days after (1) its passage and (2) approval by the Mayor, and (b) upon a single publication in the legal newspaper for the City of Two Harbors.
